Climate neutrality and its challenges



Target: Climate neutrality in AT until 2040

Energy-intensive industry has challenging transformation processes ahead



Transformation must be initiated now given the long investment cycles and plan operating cycles



Transformation of industrial processes require: Higher CAPEX; Early planning reliability; Higher OPEX



→ Need of funding instruments that are flexible, avoid overfunding and guarantee long-term planning of investment decisions

Transformation and exchange with industry

- In many of its funding measures, the BMK pursues a transformative RTI approach, which sees technological development and (system) innovations as an essential building block for overcoming the major societal challenges of the future.
- Goals of transformative policy:
 - Shaping the green and digital transformation with R&I by developing and testing technologies and system innovations for climate neutrality.
 - Advance technological sovereignty through targeted identification and realisation of innovation chances in the development of key technologies.
 - Strengthen resilience and competitiveness by building innovation capacity and future competences in the business sector, research organisations and multipliers.
- BMK launched a long-term dialogue process together with representatives of the EEIs and the Federation
 of Industry (IV) to work on a common understanding of the needs and paths of the EEI towards climate
 neutrality
